- The Performers shall provide services (concert and/or dance music) conducted by and under the auspices of the Contractor at the following time and place:

- In consideration for the performance mentioned in the preceding paragraph, the Contractor hereby agrees to pay Public Opinions Soundstage:

We accept all major credit cards. However, a 3% service fee will be added to the amount being charged.

- The Performers agree to meet in person with the Contractor (if he or she so chooses) before the night of the performance to arrange music and activities (i.e. songs for dances, cake cutting, bouquet/garter toss, etc.).
- Performers agree to confirm the performance with the Contractor before the night of the performance. The Contractor must inform the Performers of any changes to the event at least 24 hours prior to the event date.
- If for any reason the performance is cancelled, the Contractor agrees to notify the Performers a minimum of 4 weeks before the night of the performance. The Contractor agrees that only those monies previously paid to the Performers will be refunded (excluding deposit) and that no further damages will be sought against the Performers. If for any reason the Performers are unable to perform, they will acquire a suitable replacement at no additional cost to the Contractor, or the Contractor may be released from the contract with a full refund (including deposit).
- If the Contractor chooses to end the event (while in progress) in less than the contracted amount of time, the Contractor is still required to make full payment.
- If for any reason during the event dangerous conditions arise, the Performer's reserve the right to stop or terminate the contract/event (including inclement weather) to ensure their safety. A prorated fee (based upon the contracted amount) will apply only if the Performers terminate the contract/event. The contracted amount will be paid in full if the Contractor chooses to terminate the contract/event.
- The designated Emcee/DJ is not guaranteed after the contracted time. Additional hours may be purchased only if the designated Emcee/DJ is available for them.
- Payments made after the event date are subject to a \$50.00 late charge. The Contractor is liable for returned checks in addition to any late charges. A \$25.00 non-sufficient funds charge will be imposed for each returned check.
- The Contractor agrees to provide sufficient electrical power with two outlets on separate circuits within 100 feet of the designated DJ setup location.
- The Performers have the right to print, publish, and use any images or sound generated during the course of the event as promotional items such as brochures, photo album displays, and website displays UNLESS initialed by the client here_____. (Initialing here prohibits the Performers from using any media material from the event for promotional purposes).
- If food and/or beverages are being served, we ask that we be allowed to partake.
- Additional contract provisions, if any, shall be in writing, signed by an authorized representative from both parties here under, and securely attached to all executed copies of the Contract before having any force or effect.
